Ferry Festa Guidelines:

- All Vendor areas will be 20' x 20' in a spot designated by the Committee.
- Vendors must be prepared with their own display equipment and are responsible for delivery, handling, erection and removal of booth and materials. No electricity will be provided by the Village.
- On the day of the event take Elm St. to the Municipal Parking Lot behind Village Hall, where your location will be given to you. You must arrive between 11.30 and 12.30. Plan to come early and set up stress free. Any vendor arriving after 12.30 will potentially be considered "unable to appear" and will forfeit their booth space with no refund. This enforcement is to ensure a safe and smooth operation for all participants. All other rules will similarly be enforced.

By submitting this application, I agree to the following:

- The Vendor shall occupy only the space assigned. Selling a booth space is not permitted. No cars permitted in space. **No silly string, stink bombs, fake cigarettes and no poppers.**
- The Vendor is responsible for the payment of NYS Sales Tax and must have a current NYS Sales Tax Number & Certificate.
- Food Vendors must have a valid Westchester Department of Health Permit and submit a copy with the application.
- For Restaurants on Cedar & Main Street only: You must have a sidewalk license from Village Hall if you plan on utilizing the space outside of your establishment.
- The Festa Committee's sole obligation is to provide a designated space to the Vendor. Moving from assigned spaces is not permitted without Festa Committee authorization.
- The Festa Committee retains the discretion to implement or deny any application. The Festa Committee has the right to prohibit conduct which is deemed deleterious to the Festa and may remove any Vendor it feels causes any undue disruption.
- Generators must comply with the Village of Dobbs Ferry's Noise Ordinances.
- The Vendor's inability to appear at the Festa for any reason will not result in any refund, rain date included.
- Parking for Vendors will be available at the Waterfront. A free shuttle will be operating to the intersection of Cedar and Main Street. Vendors are not permitted to park on Main St. or Cedar St. during the event.
- By signing this agreement, the Vendor agrees to indemnify, defend and hold harmless the Chamber of Commerce, The Festa Committee, the Village of Dobbs Ferry, Dobbs Ferry Police Department and its members, officers, employees, agents and representatives for any personal injuries, property loss or damages suffered by any person as a result of the action of the Vendor.
